Strategic Proposal – U.S. Customs Tariffs / Civil Liability in the Ferrayé Royalties Fraud – Political Implications in Switzerland

Mr. President,

Please allow me to express my profound respect and sincere support for your steadfast commitment to restoring national sovereignty and confronting the forces of the so-called deep state that too often act beyond democratic control.

I am writing to you today as the **official legal representative of Mr. Joseph Ferrayé**, the inventor of the patented systems used to extinguish burning oil wells during the Gulf War, and as the **50% legal beneficiary of the royalties derived from these patents**. These rights have been the object of a **state-level fraud and laundering scheme**, carried out with the complicity of various international institutions, including certain U.S. entities and financial networks.

Enclosed with this letter is a **strategic diplomatic memorandum**, which outlines a **bilateral agreement proposal** aimed at resolving this long-standing matter diplomatically, within the context of the recent U.S. tariff measures imposed on Switzerland.

The Issue Goes Beyond Economics

Over the past three decades, every legal complaint filed in Switzerland regarding this matter has been **systematically dismissed**, despite overwhelming evidence. This pattern reflects the **deep-rooted corruption within Swiss authorities and judicial institutions**, and the structural impossibility of achieving justice through internal channels.

This is not the first time that U.S. authorities have been informed of this matter. In fact, official complaints and legal documentation were formally transmitted to **President Barack Obama** and to **Attorney General Loretta Lynch** during your predecessor's administration, in **May 2015** and again in **October 2016**. These included clear evidence of the fraud, laundering mechanisms, and the involvement of U.S. institutions (DEA, banks, and federal intermediaries).

Despite this, no substantive investigation was conducted, and the matter was effectively buried — which only deepens the civil and moral responsibility of the U.S. government across administrations.

Therefore, and in line with my **official candidacy for the Swiss Federal Council (March 12, 2025)**, I have clearly stated that **any agreement I may reach with you, Mr. President, must be made public**. It will serve as the **catalyst for the collapse of the current Swiss Government and its Parliament**, as set forth in my reform platform.

Furthermore, Mr. President, I believe it is essential for you to understand the human cost of this corruption. Switzerland, with a population of 8.5 million, counts approximately 1.5 million people (~18%) as living in poverty — and half of them **live below the poverty threshold. I am one of them**. The Swiss authorities have systematically ruined me, economically and socially, in order to silence my defense and prevent any legal recourse. As a result, if I am required to travel to the United States for this matter, I currently lack the financial means to do so.

This agreement, once revealed to the Swiss and international media, will stand as **irrefutable proof of Switzerland's complicity in the global Ferrayé royalties fraud**. This political shockwave will mark the beginning of a long-overdue transition toward a **sovereign, transparent, and citizen-serving Swiss Republic**.

A Historic Opportunity

I believe our interests align: **truth, sovereignty, and institutional integrity**. Together, we have the opportunity to deliver a decisive blow against deep-rooted systemic corruption. I remain at your full disposal for direct or mediated discussions with your legal or diplomatic advisors.

Please accept, Mr. President, the assurances of my highest consideration and respect.
