## 39% customs duties on Swiss exports to the USA

Dear Sir / Madam,

Playing the “startled virgin” after becoming aware of the customs duties imposed on Switzerland due to your own fault will not suffice to conceal your personal responsibility and that of your predecessors, which could lead Switzerland into an unprecedented economic crisis !

This is the result of your involvement and complicity over three decades in organized crime, fraud, money laundering, undermining the rule of law, recurring obstruction of criminal proceedings, and the contribution of members of the country’s highest authorities up to the Federal Court, which have led to this situation. You bear full responsibility!

Is it necessary to point out that, after handling the case in Geneva, you hastened to appoint Bernard BERTOSSA as Judge of the Federal Criminal Court so he could sabotage the complaints filed with this body and ensure the impunity of the CRIMINALS ?

Therefore, you will understand that if you want the Swiss people to benefit from the same privileges offered to the American people, your mea culpa must be total and without reservation...
