## **Subject: Proposal for Diplomatic Settlement – Ferrayé Case / U.S. Tariffs on Switzerland**

Mr. President,

I am writing to you once again regarding the international case involving the **FERRAYÉ royalties**, following up on previous correspondence and the **strategic memo** that has been made available to your office.

Your decision to increase import tariffs on Switzerland – now reaching 39% – is a strong and consequential move. Yet it highlights the urgent need for the Swiss authorities to acknowledge their direct complicity in the massive fraud and money laundering surrounding this global scandal.

### **1. A large-scale fraud with geopolitical consequences**

The royalties generated by the patents of Mr. Joseph Ferrayé were the subject of a coordinated and systemic theft and laundering operation, implicating U.S. institutions (DEA, banks, federal agencies), European governments, and the highest levels of the Swiss state.

The financial damages are astronomical: initially estimated at **\$3.6 trillion USD in the 1990s**, with current projections exceeding **\$97 trillion USD**, mostly laundered in **U.S. dollars** – a fact that engages the **civil liability of the United States**.

### **2. A proposal for a strategic diplomatic agreement**

As the **legal representative of Mr. Ferrayé** since 2004 and the holder of 50% of his rights, I hereby propose the conclusion of a **confidential yet decisive bilateral agreement** between you, as President of the United States, and myself, representing a Swiss sovereignty movement.

**The objectives of this agreement would be as follows :**

- ⇒ The **partial or full removal of tariffs** on Swiss exports;
- ⇒ In return: the **official renunciation of any civil claim** against the United States;
- ⇒ Without shielding the perpetrators of the fraud from criminal prosecution;
- ⇒ With a controlled public disclosure of the agreement to international media.

### 3. A political turning point for Switzerland and beyond

Such an announcement would provoke a **major political shockwave in Switzerland**, exposing systemic corruption at the highest levels and triggering the fall of an illegitimate government. This act would serve as the cornerstone for rebuilding a sovereign, democratic, and transparent republic.

Through this action, the **United States would position itself as a liberator**, and you personally, Mr. President, would be recognized as the leader who dared to confront global financial impunity. Your initiative could mark a **historic turning point**, comparable to that of **Abraham Lincoln**, freeing not only the American people, but also the peoples of Europe from the economic stranglehold of the so-called Deep State.

### 4. Proposed next steps

- ⇒ **Establishment of a secure communication channel with your legal or diplomatic advisors;**
- ⇒ **Joint review of the proposed agreement;**
- ⇒ **Strategic coordination of its public announcement at the appropriate time.**

I remain available for a meeting – virtual or in person – according to your convenience, and will provide any further documentation you may require.

**In conclusion**, the time has come to resolve this historical dispute. You, Mr. President, have a unique opportunity to act as a visionary statesman – one who restores justice for his nation and leads a worldwide effort to break a cycle of impunity.
