**Subject: Final reminder – U.S. civil liability in the Ferrayé royalties case – deadline of September 30, 2025**

Mr. President,

On August 3, 2025, I formally transmitted to you an exceptional offer of total immunity for the United States regarding its civil liability in the fraud and laundering of royalties from the Ferrayé patents. This fraud was carried out in U.S. dollars since the early 1990s and its updated value now exceeds USD 84 trillion.

This offer was conditional upon your personal commitment to :

1. A clear recognition of Switzerland's involvement in this historic fraud,
2. The opening of a process leading to the dismissal of the Swiss federal authorities complicit in it,
3. A bilateral agreement aimed at restoring the rule of law and regaining control over the laundering of these funds.

To this day, no response has been received from you.

Mr. President, you claim to want to eradicate the Deep State. The time has come to prove the sincerity of your statements. Previous U.S. governments have acted like banana republic presidencies, betraying the law and engaging your Nation in colossal financial liability.

Your silence or inaction could only be interpreted as submission to the same hidden forces you claim to fight.

It must also be emphasized that international rating agencies (Fitch, Moody's, Standard & Poor's) cannot indefinitely ignore such civil liability.

The updated value of the laundered and stolen royalties now exceeds USD 84 trillion. Such a liability, added to the current U.S. national debt, would inevitably force these agencies to downgrade America's sovereign credit rating. Such a downgrade would trigger catastrophic economic and geopolitical

consequences, directly threatening global financial stability. You are therefore faced with a clear choice: either accept this liability and drive your country into bankruptcy, or act immediately to negotiate a historic agreement that restores the rule of law and protects your citizens.

I therefore set a firm deadline of September 30, 2025, for you to officially state your position on this matter and on the willingness of the United States to conclude a fair and transparent agreement.

Failing to provide a written and signed response by this date, the offer of annulment of U.S. civil liability will be permanently withdrawn, and I will take all necessary measures to defend my rights and bring the truth to light before the international public opinion.

This case is not only financial: it concerns the future of your citizens and the credibility of the United States in the world. You now have a historic opportunity to restore the rule of law and to write a new chapter. Such a chance will not come again.

Please accept, Mr. President, the assurance of my firm and unwavering determination.
